Medical School: Graduation from a medical school in the United States which at the time of the applicant's graduation was accredited by the Liaison Committee on Medical Education, a school of osteopathic medicine approved by the American Osteopathic Association, an accredited medical school in Canada, or from a medical school located outside the United States and Canada that is deemed satisfactory to the Board. Current License(s): Unrestricted, currently valid license(s) to practice medicine in a State, the District of Columbia, a Territory, Commonwealth, or possession of the United States or in a Province of Canada. No license may be restricted, revoked, or suspended or currently under such notice.	Required for all pathways			
Clinical Training: Supervised postgraduate clinical training provided as part of a graduate medical education program accredited by the ACGME. Clinical training accredited by the American Osteopathic Association, the Royal College of Physicians and Surgeons of Canada or the College of Family Physicians of Canada is also acceptable. The training must include at least six months of direct patient care comprising ambulatory and inpatient experience per each 12 months of training. Required Coursework: Successful completion of graduate level courses in the core areas of a Master of Public Health or equivalent postgraduate degree program. Residency Training: ACGME-accredited residency training in the specialty area (Aerospace, Occupational, Public Health and General Preventive Medicine) for which certification is being sought, including an MPH degree or equivalent. Currency: The applicant must have been engaged in current, essentially full-time training for, or practice in, preventive medicine. \*\*\*Alternative Pathway applicants are allowed to apply full-time practice in the specialty area for which certification is being sought, along with the four core courses, toward fulfilling the academic and residency training requirements. See Practice Years table to equate the total number of years required.

***This form should only be used by applicants who graduated from medical school before January 1, 1984 only and are applying through the Alternative Pathway for specialty certification.***
